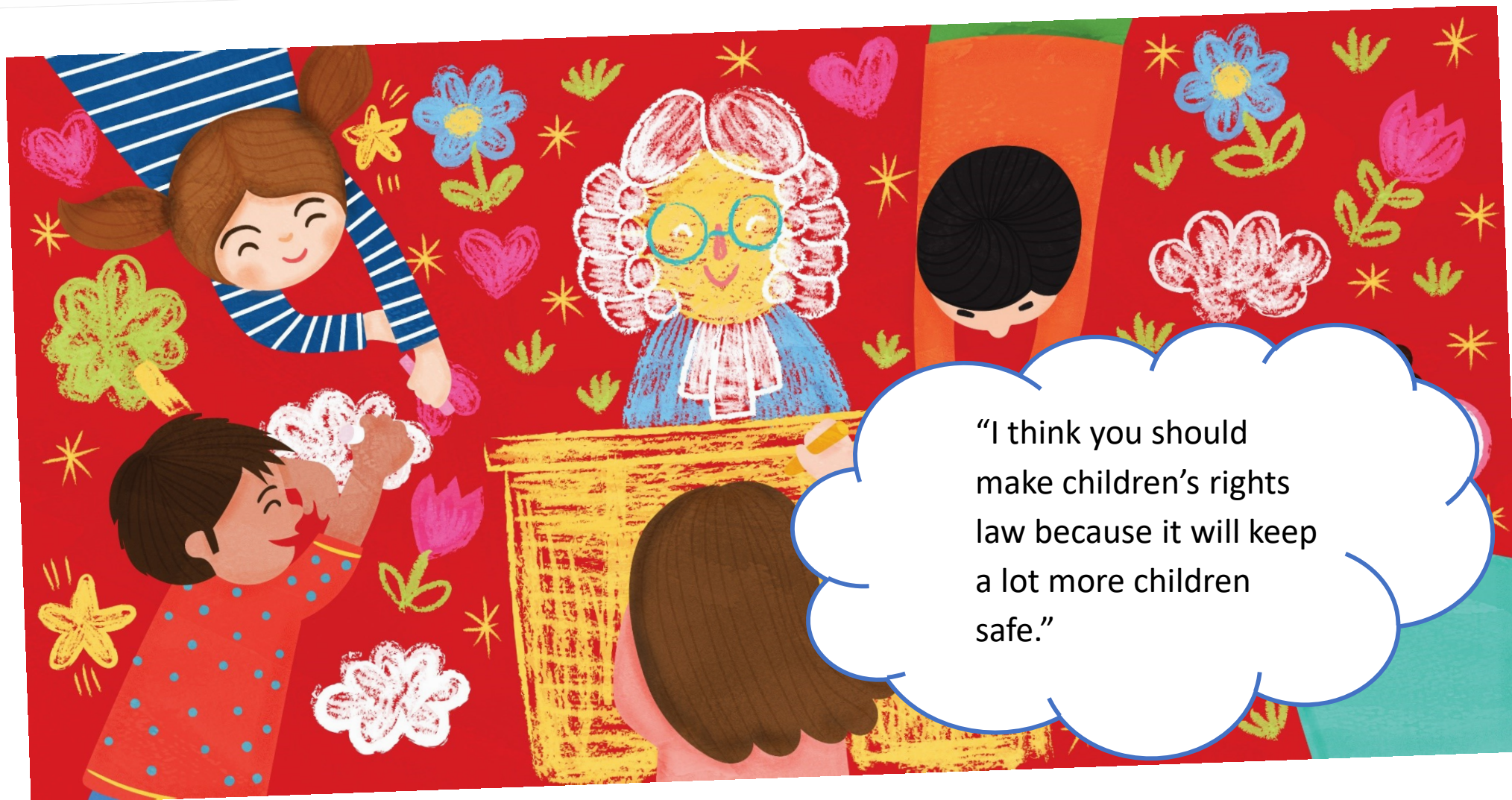

This will help to ensure that children's human dignity is respected and all children are supported to thrive and reach their full potential

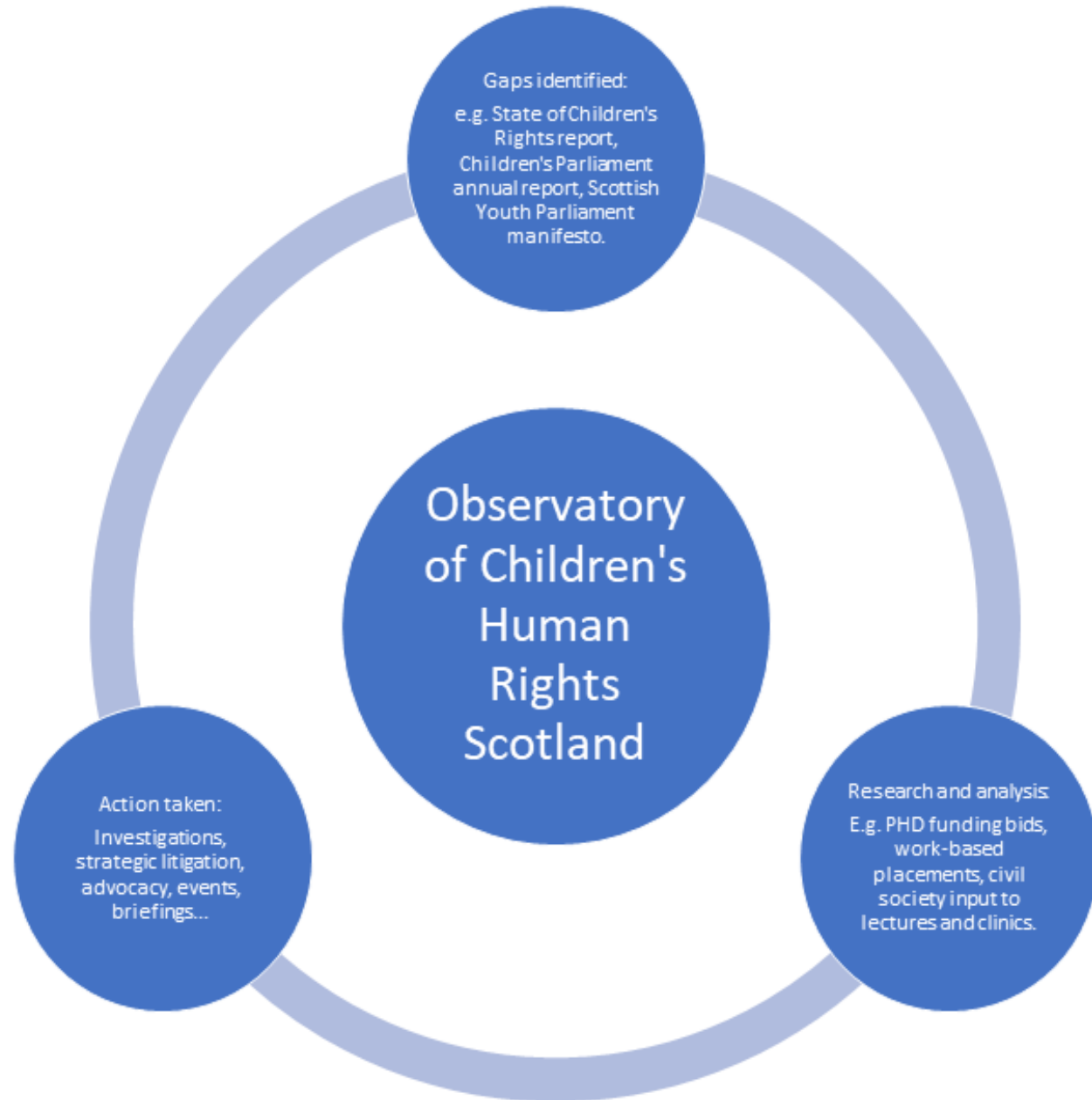
